Comes now Bessie Nephews, plaintiff, and for her cause of action against the defendant, Alex Nephews, alleges as follows.

First. That the plaintiff and defendant were married at Grand Island, Nebraska, on October 12th, 1915, and that ever since the year 1917 up to the filing of this suit, both the plaintiff and defendant have resided in Fairbury, Jefferson County, Nebraska, and that the plaintiff has always conducted herself, towards the defendant, as a faithful, chaste and obedient wife.

Second. The plaintiff further alleges that the defendant regardless of his marital duties as a husband, was guilty of extreme cruelty towards the plaintiff without any cause or provocation on her part; and that on or about the first day of December, 1930, the defendant did strike and hit the plaintiff with a pair of tailors shears and did inflict a wound upon the scalp of the plaintiff and also that the defendant did curse and swear at the plaintiff and put her in fear of physical injury of his hands. Plaintiff promised to continue to live with the defendant upon his taking treatment for his drinking habit and which the defendant took, but that he returned from such treatment about three weeks thereafter and for the last two or three months prior to the 19th day of June, the defendant was continuously abusing and threatening the plaintiff and that he would curse at her until the same became unbearable and that she did on said 19th day of June, 1931, leave the said defendant.

Third. The plaintiff further represents that said defendant wholly regardless of his obligation to the public for the last two years next before the filing of this petition commenced the excessive use of intoxicating liquors and has for the last two years or more next before the filing of this petition been an habitual drunkard.

Fourth. The plaintiff further alleges that on June, 19, 1931, a property settlement was entered into in writing between the plaintiff and defendant.

Wherefore the plaintiff prays that she be granted a divorce from the defendant and that the court approve the property settlement entered into between the plaintiff and defendant and that she have as her own and separate property such property as is set apart to her in the property settlement, and for costs of suit.
